Comments related to specific agenda items will be able to be made when the item is discussed. If your matter needs to be discussed in more detail, you should attend the City Council's monthly Coffee With Council Session or present your comments in writing.

A member of the public may request that a Consent Agenda item be removed from the Consent Agenda. The Mayor may ask the person requesting removal to provide a brief explanation of the reason for the request. The item will be removed from the Consent Agenda upon the concurrence of any member of the City Council. If the item is not removed, the member of the public may address the Consent Agenda item during "Citizens to be Heard."

Resolution

WHEREAS, The Illinois Prairie Path runs through the heart of the City of Wheaton and has been cared for by Wheaton citizens since it was founded in 1963; and

WHEREAS, Thousands of Wheaton volunteers have dedicated thousands of hours to preserve its natural beauty; and,

WHEREAS, The City of Wheaton has enjoyed and embraced the beauty of the mature trees and native plant species in our community and along the Illinois Prairie Path; and

WHEREAS, Wheaton residents value the positive impact these trees and native vegetation bring to our quality of life and property values;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council together with the Wheaton Environmental Improvement Commission that the City recognizes there is a rising public discourse regarding the aggressive tree trimming and the elimination of swaths of native vegetation along the Illinois Prairie Path by Commonwealth Edison and its contractor Asplundh.

BE IT FURTHER RESOLVED that the City of Wheaton supports the ongoing efforts of its citizens to protect the trees and trails and believes they should be protected.

BE IT FURTHER RESOLVED that the City of Wheaton and its' citizens call for Commonwealth Edison and the County of DuPage to promptly develop a comprehensive management plan for IPP vegetation with an emphasis on native plantings and addressing invasive species.

BE IT FURTHER RESOLVED that the City of Wheaton petitions the Illinois Commerce Commission - I.C.C. for a public hearing to be held to discuss and resolve these important matters.
